#### II. Essay Question (25 points)

Two of the following will be on the exam, and you will answer one.

## 1. Discuss the discrepancy between British colonial theory and practice between 1660 and 1763.

- a. How did the British think about their empire? What steps did they take to put their theory into practice?
- b. How was the British theory complicated by colonial developments and practices by 1750?
- c. What event brought the discrepancy between theory and practice into the open?
- d. Might we see the discrepancy between British colonial theory and practice as the origin of the Revolution?

# 2. Characterize the colonial protest to British authority between 1763 and 1773?

a. In this essay you must focus on the <u>colonial responses</u> to British acts, not on the acts themselves.
b. In addition, your discussion of the colonial protest must present <u>an argument</u>. You should <u>characterize</u> the protest, not simply discuss the events of the period.

## 3. Discuss the radicalization of the American position between 1774 and 1776.

a. What affect did the fighting at Lexington and Concord have on the colonial position?

b. How did the colonial argument change during the early meetings of the Second Continental Congress?

c. How did Thomas Paine's Common Sense change the colonial position?

d. Finally, how did Jefferson's Declaration of Independence change the course of the American Revolution in 1776?

# 4. Compare and contrast the Articles of Confederation with the U.S. Constitution.

- a. What type of government did the Articles of Confederation create, and what did it "look like?"
- b. What were the problems with the Articles of Confederation?
- c. What type of government did the Constitutional Convention create in 1787?

d. Did the government established by the Constitution suffer from the same problems as those faced by the Confederation government?
